Applicants are therefore advised to apply only at the end of the stated academic session.

In a letter signed by the Acting Director, Personnel Affairs, M. S. Aminu on 16th April, 2012 and copied to all the heads of Department and Deans of Faculties, all the Heads are urged that they should not endorse any recommendation or application for sabbatical leave.

Appointments And Reappointments

The Vice Chancellor, Professor Abubakar Adamu Rasheed mni, has approved the appointments of:

- 1) Professor Abdulrazaq Garba Habib, as Dean, Faculty of Medicine with effects from March 16, 2012.
- 2) Dr. Abdullahi Bichi Baffa, as Director, Centre for Information Technology (CIT) with immediate effect.

And the reappointments of

- 3) Dr. S. R. Yusuf, as Head, Department of Crop Protection with effect from January 25, 2012.
- 4) Dr. Abdu Lawan, as Head, Department of Ophthalmology with effect from June 2, 2012.

All the appointments and reappointments are for a period of two years.

Streamlining Sponsorships and Fellowships

Following the University Management Committee’s approval of recommendations of the Committee of Deans and Directors, a number of aspects on sponsorships and study fellowships for the training of academic staff has been streamlined. The details are as follows:

1. Conditions for Sponsorship and Study Fellowship

The following general guidelines on sponsorship and study fellowship for various categories of academic staff are now in place.

- a) **Sponsorship and Fellowship Abroad:** Only confirmed members of staff qualify for sponsorship by the University for study **abroad** (subject to the availability of funds). Such sponsorships could be from MAGIC, TETFund, PTDF and other types of grants and could cover Ph.D and Masters Programmes. Such staff could be awarded study fellowships and shall be **bonded** for the duration of period of study.

- b) **Study Fellowship Only:** **Unconfirmed** members of staff who secure full external sponsorship for Ph.D or Masters abroad qualify for award of study

fellowship only. For those going for Masters degrees, the Committee of Deans and the Directors will take into account the nature of the programme and staffing situation in their Department in deciding whether to recommend the study fellowship or not. The University shall continue to pay the salaries and allowances of those awarded the study fellowship. They are to be **bonded** also.

- c) **Return After Masters Programme:** When an unconfirmed member of staff is awarded a study fellowship under (b) above, he/she must return to the University and discharge the bond signed before qualifying for sponsorship for a PhD by the University. However, the study fellowship and bond could be extended to cover a Ph.D programme if the concerned staff secures another full external support for the degree programme.

2. Types of Study Fellowship

For the purpose of bonding, Study Fellowship is now classified into two – full-time and part-time, as follows:

- a) **Full-Time Study Fellowship:** This is for all study fellows studying outside Bayero University, be it aboard or in other Nigerian Universities – irrespective of whether they are being sponsored or not. Such study fellows are to be bonded and expected to pursue their studies on full-time basis. They should be relieved of all departmental and faculty responsibilities to enable them to concentrate on their studies and complete the programmes within the shortest time possible.

- b) **Part-Time Study Fellowship:** This is for all study fellows pursuing their studies in Bayero University. They are expected to concurrently carry on with their normal duties (but with reduced workload, so that they could graduate within the stipulated period). They are to study on part-time basis and **shall not be bonded**.

3. Living Expenses and Warm Clothing Allowance for Fellows Abroad

The following **harmonized** rates of living expenses and warm clothing allowance for those on full

sponsorship by the University (irrespective of the source of support) are applicable:

- a) **For Metropolitan London and large American Cities:** \$1,300 per month.
- b) **For Western Europe and Other Parts of UK and USA:** \$1,200 per month.
- c) **For All Other Countries:** \$700 per month.
- d) **Warm Clothing Allowance:** A once-off payment of \$200 for those studying in temperate countries.
- e) **Book Allowance:** \$1,000 paid only once.

4. Beneficiaries of TETFund Local Scholarship

The Tertiary Education Trust Fund (TETFund; formerly Education Trust Fund, ETF) has clarified that the scholarship given to those pursuing their studies in Nigeria is meant to cover all the aspects of their studies. These include the payment of tuition fees, book allowance, and the like. All the beneficiaries of such scholarship should therefore take note of this development.

5. Conference Attendance For Study Fellows Abroad

Staffs on study fellowship abroad do not qualify for sponsorship to attend any conference throughout the duration of the fellowship.

6. Departure of Staff Granted Fellowship Before Discharging Bond

Staff granted full-time fellowship must on return serve the University continuously for at least the period spent on the fellowship before being released on Study Leave, Research Leave, Leave of Absence and the like. Those who wish to leave the service before discarding the bond should be required to pay for all the expenses incurred on them proportionate to the period left unserved.

7. Minimum Service After Sabbatical

Staff who went to Sabbatical must be required, on return, to serve for at least one year before they are released on Leave of Absence, Study Leave, Research Leave and the like.

Deans, Directors and heads of Department are requested to bring this to the attention of their staff for guidance.

Deadline – May 14th, 2012

This competition is open to all young professionals (**25-40 years**) in sub-Saharan Africa (SSA), North Africa and the Diaspora¹. It seeks to promote scientific excellence and **recognize and reward** outstanding young professionals who are undertaking innovative communicating the outputs (knowledge, technologies and approaches) to improve agricultural performance and socio-economic development in Africa.

Who Can Participate?

Young nationals of all African countries are encouraged to participate. Individual and group entries will be accepted. The role and contribution of the young professional(s) must be clearly demonstrated in group submissions. Entries should demonstrate effective partnerships and combination of skills and/or engagement with peers and/or rural communities.

What is the Scope?

Any science, technology and innovation (ST&I) related activity linked to the topic **“Feeding 1 billion in Africa in a changing world”**, which has been undertaken within the last five years and whose measurable impact (potential or demonstrated) **on agricultural development or rural livelihoods of African communities**. Thematic areas include: agricultural productivity and food security; postharvest and value addition; policy; environmental and eco-system sustainability; economics and trade; knowledge management and ICT; and agricultural machinery/engineering. Communications strategies, methods and tools used to disseminate results – scientific findings, knowledge, technologies, or approaches must be included.

Guidelines:

Entrants must submit a two-page (A4) abstract (**1500 – 2000 words**) that clearly details the successful ST&I project. State the title, objective(s), methodology/approach, results, discussion, conclusion, information and communication strategy, and impact (potential or demonstrated). Included the heading **“Young professionals in Science”** and full contact details; name, mailing address, telephone and fax numbers, e-mail address and proof of age and citizenship. Abstracts should be e-mailed to schcom2012@cta.int and copied to infor@fara-africa.org. The

deadline for submission is **May 14th, 2012**. Abstracts received after the deadline will not be considered.

Evaluation (Stage I):

Abstracts will be evaluated by a panel of experts including scientists, policy makers, farmers, gender and information and communication experts. Semi-finalists will be announced on **16th July, 2012**. Semi-finalists are required to submit full draft papers of not more than 4 – 6 pages by **August 20th, 2012**. The **top 20** young professionals will be invited to attend the Scientific Writing Workshop, which will be held in conjunction with the 3rd reform bi-annual conference, in **Dar Es Salam, Tanzania** from **September 24-28, 2012**.

Evaluation (Stage II):

Final papers are due **16th November, 2012** after completion of the scientific writing course. All semi-finalists who fulfill the requirements will be invited to attend the **Finals and Award Ceremony**, which will be held during the **6th Africa Science Week and FARA General Assembly** scheduled for **June 2013**, in **Accra, Ghana**. The **top 10** finalists who will compete for the cash awards, prize and trophies will be notified of the requirements in April, 2013.

Forum for Agricultural Research in Africa (FARA), the African Network for Agriculture, Agroforestry and Natural Resources Education (ANAFE), the International Foundation for Science (IFS), the NEPAD Planning and Coordinating Agency (NPCA), and the Regional Universities Forum for Capacity Building in Agriculture (RUFORUM), in collaboration with the Alliance for a Green Revolution in Africa (AGRA).

Inventory of Research Equipment

This is to inform all Heads of Department, Units and Deans of Faculty that the University Management has constituted a committee on research equipment policy. Part of the terms of reference of this committee is to conduct a comprehensive audit of the research equipment available in all Departments/Units of the University. To this effect, you are kindly requested to forward a list of such equipment in your department. Technologies in various laboratories/workshops/studios are expected to complete the forms in respect of the equipment under their custody.

The inventory encompasses all research equipment both functioning and non-functioning, as well as the new ones, which have not been

commissioned or installed. However, non-specialized equipment, which are usually many in number and are used for routine undergraduate practical teaching, should not be included. Completed inventory forms should be submitted to Dr. Ahmed A. Yakasai (Department of Chemistry) or Malam Musa Beli (Central Laboratory, BUK Old Campus) at most by 30th April, 2012. The committee will subsequently make a visitation to the departments for on-site evaluation and discussion on other important issues related to the equipment and not covered by the inventory.
