Professor Mustapha Ahmad Isa of Department of English and Literary Studies has been appointed as new Vice Chancellor of of the Management Information Systems Unit Northwest University, Kano by the Governing (MIS). He was born in May 1965, at Yola Council of the University.

Chairman of the Governing Council, Malam Sule Yahaya Hamma, said, "the Governing Council of Northwest University, Kano, in the exercise of the powers conferred on it by the Northwest University Law No. 8 of 2012, at its meeting held on Thursday, 19th March, 2015 considered the submission from Selection Board and hereby approve your appointment as the Vice-Chancellor Northwest substantive of University, Kano for a period of five years with Prof. effect from Monday, 4th May, 2015."

Until his appointment, Professor Mustapha Isa was the Director Academic Planning in Bayero University.

Professor Mustapha Isa obtained a PhD in Linguistics from Indiana University, Bloomington, U.S.A. His special areas of morpho-syntax, interest are lexicology, semantics and new Englishes.

He is the (co-) author or (co-) editor of over 35 academic publications mainly in Linguistics and Democratic Studies.

Professor Mustapha Ahmad Isa is a Professor of English Language, the Director of Academic the Planning, and member of the Bayero University Governing Council. He is also a former Director Quarters in Kano city. He obtained a Primary School Certificate from Shahuci Primary School A letter signed by the Pro-Chancellor and in 1977, and a Grade II Teachers' Certificate, from the School for Arabic Studies (SAS) in 1982. He had a B.A. Hausa (Language) degree from Bayero University, Kano in 1987, missing a First Class by a fraction of a parentage. He later obtained an M. A. in 1990 and a PhD in 1994, from Indiana University, Bloomington, USA, with a Major in Theoretical Linguistics, and a Minor in Applied English Linguistics.

> Mustapha Isa has been with the Department of English and Literary Studies, Bayero University Kano, since 1994, where he has taught virtually all the courses in the language section – undergraduate, PG Diploma, Masters and PhD. He has co-authored nine books and published 32 articles in Universitybased journals and chapters in books. Some of his works were published in the USA, Germany, Poland and the United Kingdom.

> Prof. Isa has supervised numerous B. A. projects, Masters theses, and PhD dissertation in areas of English Language various and Linguistics. For 15 years, he has served as an External Examiner in five Federal and three State Universities in Nigeria. During this time, he has examined over 50 Masters and 17 PhD candidates, mainly in the areas of

NASU Election Ends in Deadlock **Caretaker Committee to be Appointed**

The election for new executive members of the Non-Academic Union of Universities (NASU). BUK branch has ended in deadlock following a document read at the venue of the election barring some candidates from contesting.

The members of the union who besieged Theatre One Old Campus, venue of the election as early as 9am to cast their votes went back home frustrated, with many accusing the national body of the union of partisanship.

After the dissolution of the former executive the NASU General members, Secretary, represented by Mr. Augustine Gabriel read the document which he said was a prerequisite for the conduct of the election.

Part of the document was that in any election some posts are reserved for women, and in an event where a woman is contesting with men that post must be given to her.

As soon as he read this, it automatically disqualified the contenders for the position of treasurer, where a woman happened to be among the contestants and the position was among the keenly contested. This caused serious stir that led to the cancellation of the election.

document was given to the former executives to notify the congress about the new development. He said it was clearly stated by the International In addition to teaching and research, Prof. Isa Labor Organization at the conference held recently that women must contest in any election of organized associations in order to give them a pride of place in the scheme of things.

> In a swift reaction, former Secretary of the union, Malam Rufa'i Idris debunked the claim made by the NASU chieftain and said that the document was given to the BUK leadership barely 24 hours into the election, "which is too late for us to call the congress members and notify them."

> In an interview with some members who pleaded anonymity, they alleged that there was a serious conspiracy in the election to pave way "for some people."

> Following the cancellation of the election, a caretaker committee will now be appointed to steer the activities of the union pending a new date for election.
