



Inter-Basin Water Transfer Solution to Restoring Peace, Security, Livelihood in the Lake Chad Basin – FAO

The Food and Agriculture Organization (FAO) has recommended that a far-reaching solution to restoring peace, security and livelihood of the Lake Chad Basin is to transfer water to the lake from the Congo Basin, connecting the River Congo to the Chari River that flows into Lake Chad. This will address the daunting hardship faced by millions of people living in the area.

Even though it is a multi-billion dollar project, FAO called on the African Development Bank (AfDB) to facilitate the creation of the Lake Chad Fund of US \$50 billion to be sourced from African states and donations by Africa's development partners to fund the Lake Chad project and other infrastructural projects in order to restore peace to the Lake Chad.

The Country Director of FAO, Mr. Suffyan Koroma, suggested this during one of the technical sessions of the 3rd International Conference on Drylands organized by the Centre for Dryland Agriculture (CDA) in collaboration with ICRISAT and IITA on 27th September, 2018, titled: **The Chad Basin: Revitalizing Livelihoods and Ecosystem.**

Mr Koroma said the Lake Chad Basin, shared by eight countries including Algeria, Cameroon, the Central African Republic, Chad, Libya, Niger, Nigeria and Sudan, is one of the largest fresh water bodies in Africa and occupies about 8% of the continent's size. An estimated 12% of the over 370 million people in these countries live around the lake and depend on it for crop and livestock farming, fishing, commerce and trade. Due to climate change and human activities, the size of the lake has reduced from 25,000 km² to less than 2,500 km² between 1963 and 2017, roughly 10% of its original size.

The Country Director, who was represented by Ahmed Matani, observed that degradation of the resources in the basin was partly responsible for the security challenges around the region and that climate change and unsustainable agricultural practices contributed to rainfall variability in the region, a situation that was having a direct impact on millions of people who depend on the basin's resources.

With water and vegetation retreating fast, communities around the Lake are coming under pressure – and into conflict,” he said.

The region he said was a hub for terror groups like *Boko Haram* and "Islamic State" (IS), which could also serve as a bastion for security threat to Europe. He added that crisis had unfolded in the region beset by chronic fragility, where poverty, unemployment and a lack of prospects for young people fueled extremism and were compounded by environmental degradation and the impacts of climate change.

Research has shown that more than 10 million people are in need, 7 million severely food insecure 2.3 million people displaced, 515,000 children acutely malnourished and more than 220,000 people from the region classified as refugees.

The movement in search for pastures deeper southwards has led to the deadly clashes in Nigeria and in parts of West Africa between herdsman and farmers. The violence in the region has driven tourists away and destroyed entire economic sectors, such as agriculture. The insurgency by the militant Islamist group (Boko Haram) has also led to a catastrophic decline in agricultural production, the mainstay of the region,” FAO Country Director explained.

Lake Chad's horrible fortunes can be reversed through a comprehensive programme of action to save it from total extinction. He noted that attention should not only be paid to the specific situation in each of the affected countries but also the interdependencies across the region - cross-border dimensions, such as refugee movements,

including possible returnees.

He said International co-ordination on the ground already existed, especially through the military alliance formed to fight the *Boko Haram* insurgency with greater effort into the inclusion and integration of local communities and civil society groups in the design, implementation of

interventions for the restoration of the Lake Chad Basin.

FAO also recommended that more longer-term development investments are needed to re-establish civilian government presence and services, build resilience and address the underlying vulnerabilities and conflict drivers.

A Professor of Islamic Economics in the Department of Islamic Economics, University of Southern California, Professor Monzer Kahf, who gave the advice in a paper he delivered, titled *SUKUK and Sustainable Development* on Tuesday, 18th September, 2018 at Mahmud Tukur Theatre, Old Campus, revealed that the system in addition to being interest free provides a leeway for viable economic ventures.

The guest speaker, who was impressed by the hospitality shown to him by the University management, said that Bayero University had a brighter potentiality of becoming a leading University in the country by growing fast if it could adopt the concept of *SUKUK* in its services.

Earlier, in her welcome address, the Director of the International Institute of Islamic Banking and Finance (IIIBF), Professor Binta Tijjani Jibril, said the lecture was specifically organized to enlighten members of the public about the concept of *SUKUK* and its significance towards economic rejuvenation.

The Director pointed out that the system was a veritable engine of sustainable economic growth and development suggesting that, Nigeria, being a potential economic super power was no doubt on the verge of achieving success in its drive to improved economic activities.

She said the IIIBF was established with a view of bringing to the fore Islamic Finances as well as other ideas and concepts' in line with the global best practices so as to serve as a vehicle of the conveyance of positive economic changes to the society.

The University of Silesia in Katowice, Poland and Bayero

University, Kano, had signed a Memorandum of Understanding (MoU) on 8th June, 2017 with Dr. Abdullahi Arabi Suleiman as the linkage coordinator in Bayero while Dr. Ewa Kurowska represented the University of Silesia. The agreement was signed in order to develop tasks of international education and to carry out joint research programmes so as to widen dialogue between academic staff and students and to work out a better understanding between the two nations.

Apart from the GIS and specialised software training, fellows also embarked on a field trip to study environmental impact of quarry sites and also conducted field study of tree species around the region of Silesia.

The event which took place at Mahmud Tukur Theatre, Old Campus on 4th October, 2018 witnessed large turnout of Bayero University female staff.

The CEO, Nigerian Women's Trust Fund, Mrs. Mufuliat Fijabi, and Dr. Muhammad Mustapha Yahaya, the Executive Director, Centre for Dispute Resolution and Development Initiative, who earlier paid courtesy visits to the Vice Chancellor and the Registrar in their offices, both presented papers at the occasion.

In her presentation, Mrs. Fijabi pointed out that it was important for professional women in the likes of ASUU, NASU and SSANU to participate in sensitization and to support women political participation in Nigeria, especially in the forthcoming 2019 general election. Nigeria with no single women representation in the whole northwest geopolitical zone at the National Assembly.
