#### **GUIDELINES FOR SUBMISSION OF ARTICLES**

Articles to be published should contain original research work, or a scholarly review work. Short articles and book review articles within the scope of the journal may be considered provided that the length does not exceed 12 pages of A4 paper, type doubled spacing.

# **ABSTRACT**

The abstract should be structured and be between 200-250 words; and should state the significance and objective of the work, methodology or techniques applied, as well as the main findings / contribution of the work. It should also include key recommendations.

## TABLE

Table should be self-contained and complement, but not duplicate information contained in the text.


