



BUK On-Campus Students Work Scheme for Launch Today Friday

The Vice Chancellor, Professor Sagir Adamu Abbas will today launch the on-campus students job introduced recently.

The scheme which was in fulfilment of the desire of the Vice Chancellor to alleviate the difficulties and challenges faced by students due to lack of adequate financial support, takes-off in December, 2021. The scheme provides opportunity for students from across the faculties to work and earn some income.

The scheme will be launched today, Friday, 3rd December 2021 at Musa Abdullahi Auditorium by 3:00pm.

Over 2000 students applied but only 948 submitted their applications within the deadline and were considered.

So far, 125 students were selected to participate and the management has also made a reserve list for replacement of those who will leave the scheme for various reasons. The duration of the appointment is for a semester and the student may wish to re-apply on the following semester. Students may at any time wish to withdraw from the scheme by giving one week notice in writing.

The scheme has made provision for adequate supervision of the students and they will need to have a clearance form signed before payment which is planned to be made weekly. The Vice Chancellor congratulates those who were selected and advised them to be dedicated to the work assigned to them while maintaining discipline, and continue to pay attention to their studies.

HJRBDA To Construct Tube Wells in BUK ...To Address Water Shortage

The Management of Hadejia Jama'are River Basin Development Authority will construct tube wells in Bayero University New Campus to assist University in addressing the perennial water shortage bedevilling the institution.

The Authority's Assistant Director in charge of Dams Department, Engineer Suleiman Muhammad has disclosed.

He was speaking during an on-site inspection by a team of the Authority's engineers and professionals from Bayero University to determine suitable site for the construction of Earth Dam for the University. The team, after the site inspection, proposed an area within the faculty of Law as the site for the proposed earth dam.

Engineer Suleiman said sequel to the recent letter by the Vice Chancellor to the Minister of Water Resources, Engineer Suleiman Adamu requesting for the ministry's intervention to construct an earth dam as a long term solution to help address the persistent water scarcity facing the University, Engineer Suleiman said the Authority decided to visit the University to meet and discuss with professionals in the University including the Vice Chancellor on the possibility of constructing earth dam as a long term solution.

He, however said since the earth dam project is a long term one, the Authority he said decided to opt for a short term

measure by constructing three tube wells attached with overhead tanks at suitable location within the Campus pending the conclusion of geophysical Engineering investigation.

The HJRBDA Assistant Director assured the Vice Chancellor that the Authority would do everything

BUK Attracts Over One Billion Naira Research Grants in 3 Years – VC, Prof. Abbas

Bayero University, Kano has attracted more than one billion (N1b) funds for research and development in three years, Vice Chancellor, Professor Sagir Adamu Abbas, has said.

The Vice Chancellor was speaking on Friday, 26th November, 2011 when he received a delegation of the first set of BUK graduates ABC-ABU led by the Chairman of Board of Trustees, Professor Bello Ahmad Salim, in his office.

The Vice Chancellor made reference to the N442 million research grant won by the University from TETFund through a team of researchers last year, saying that this year's grant was more than the earlier one. He said there would be another trench of research grant next year. "The University has attracted more than N1billion in three years," he emphasized.

Recall that twelve research groups applied for the TETFund national research grant and all the groups competed and won the grants totaling 422,735,622.25 Naira. He said Bayero University had moved fast in terms of research and development.

Prof Abbas informed the first generation graduands that the foundation they laid to put the University on the right pedestal had been strengthened, noting that the University's culture of attainment of excellence in all ramifications are being pursued with vigor.

He told the delegation that the University had in the last few years made massive transformations with 19 faculties, over 13 directorates and the staff population of over 7,000 and 250 Professors, including Readers.

The Vice Chancellor expressed the University's readiness to support the first AGM of the alumni and to serve as chief host.

Earlier in his remarks, the Chairman Board of Trustees,

Professor Bello Ahmed Salim, said the pioneer alumni had decided to form an association with the aim of giving back to their alma-mata, saying that BUK had a long standing history and culture that should always be preserved. He took time to recall some memorable moments in the 60s and 70s when the University was growing, pointing out that the foundation laid had continued to manifest in the quality of graduates produced who could shoulder any responsibility and excel anywhere in the country.

Prof Salim told the VC that the alumni had decided to hold its inaugural AGM on Friday 14th January, 2022 at Mahmud Tukur Theatre, explaining that it was the first theatre in the University, which they were all familiar with.

Other alumni members present at the courtesy call were Faruk Lawal Yola, Professor Kamilu Sani Fagge, Mahdi Abubakar, Hadi Mahmud Imam, Hajiya Uwani and Ishaq Mahmud Umar.

They commended the University for recording massive transformation and thanked the Vice Chancellor for graciously accepting to accommodate other guests and host the AGM as well as serve as chief host.

NCC Partners BUK on Telecom Consumer Protection

The Nigerian Communication Commission (NCC) will partner BUK in its determined effort to protect the rights of telecom consumers. This was disclosed by the Commissions Assistant Director Consumer Affairs Bureau, Mistura Aruna.

She was speaking at the fourth edition of Telecom Campus Conservation, titled: "Telecom Consumer Right Awareness: The role of statements" on Thursday 25th November, 2021 at the Deanery of Student Affairs.

The Telecom Campus Conversation forum was one of the consumer centric initiatives of the NCC targeted at creating awareness for University students on their rights and obligations as telecom consumers.

According to her, BUK was selected to host the event because of its academic excellence and commitment, hence the need to partner with BUK on consumer protection, information and education, which she said, were important on the commission's mandate.

Hajia Hafsat Lawal, who expressed her delight at the turn out of students for the event, explained in her presentation that the Nigeria Communication Commission (NCC) an independent regulatory authority for telecom industry in Nigeria was mandated to protect the rights of consumers, which included the right to receive clear and complete terms and conditions for service agreement and also to be

protected against fraudulent and misleading information by telecom providers.

She said telecom consumers had the right to personal privacy and to protection from unauthorized use of their records and personal information and also to reject intrusive communication and technology.

Engineer Ibrahim, the Director and Project Manager, who spoke on the awareness of SIM and NIN integration, said NIN was a unique number issued to Nigerian citizens and could be used to track criminals through their identity.

He said NCC and telecom operators had done a lot to curb the incidences of fraudulently registering SIMs with the false identity.

He said Federal Government mandated all Nigerian citizens to link their SIM with their NIN because criminals use mobile phone to perpetrate crime. The Director, New Media, defined cybercrime as a criminal activity in which computers or networks were used as a tool or target.

He said there was the need to create awareness on cybercrime and security because all sorts of criminal activities happened on the internet and a lot of people went

on line mainly to perpetrate crime and there was the need to protect one's online account information and data.

The Dean of Student Affairs, Prof. Shamsudeen Umar, in his remarks, commended NCC for its impactful lecture and analysis to educate students on their rights and obligations as telecom consumers, which he said was a step in the right direction.

He reiterated the importance of safeguarding telecom infrastructure which he said would create a lot of problems if destroyed.

TETFUND NATIONAL RESEARCH FUND (NRF) 2021 GRANT CYCLE: CALL FOR CONCEPT NOTES

INTRODUCTION

Following the successful completion of the processing of the Research Proposals submitted to NRF under the 2020 Grant Cycle, culminating in the total award of close to N6.4 billion to support 217 research projects, the Tertiary Education Trust Fund (TETFund) wishes to inform the Nigerian Research community, in particular, and the public in general, that the Federal Government has approved a total sum of N8.5 billion for the current 2021 Grant Cycle. The process of accessing the 2021 NRF grant involves the response to this Call-for-Concept-Notes by the Principal Investigators of the proposed Research Projects, to be followed by the submission of Full Proposals by only those whose Concept Notes have been evaluated and the Research Projects are considered fundable.

THEMATIC AREAS FOR THE 2021 GRANT APPLICATION

The twentyeight prioritized thematic areas of Research are in three categories: Humanities & Social Sciences, Science, Engineering, Technology & Innovation and Cross-Cutting.

ELIGIBILITY

Lecturers in any of our Public Tertiary Institutions in Nigeria are eligible. Multi-Disciplinary and Interdisciplinary Research Projects, comprising Researchers from various disciplines, are most highly encouraged. The Principal Investigator (PI), who must preferably be at least a Senior Lecturer in a University, Chief Lecturer in a Polytechnic or College of Education, will lead the Research Team and be personally responsible and held accountable for the conduct of the research. An added requirement is that the PI must be institution based, with the PI's institution regarded as the Coordinating Institution. However, in line with the approval of the Board of Trustees (BoT) of TETFund, additional members of the Research team can be drawn from Researchers in Private Tertiary Institutions, Research Institutes, Centres of Excellence and the Industry. This is consistent with the global best practice of involving non-governmental organizations and other non-state actors in Research Projects that are to address national needs.

APPLICATION PROCEDURE

The process of application is entirely on an online platform. The Principal Investigator is expected to visit nrf.tetfund.gov.ng where he or she will be closely guided on the preparation and final submission of the Concept Note.

All the submitted Concept Notes will be evaluated by the National Research Fund Screening and Monitoring Committee (NRFS & MC). The PIs of the successful Concept Notes will be communicated to proceed to the preparation of the Full Proposals which will also be processed online. The PI and, at least a member of the Research Team of an adjudged fundable proposal, shall be invited to defend their proposal before the NRFS & MC. Thereafter, the successful proposals for grant awards will be presented to the Board of Trustees of TETFund for approval.

DEADLINE FOR SUBMISSION OF CONCEPT NOTES

The Portal will be opened for the submission of Concept Notes from November 29, 2021 and the deadline for submission of concept notes shall be on or before December 28, 2021.
